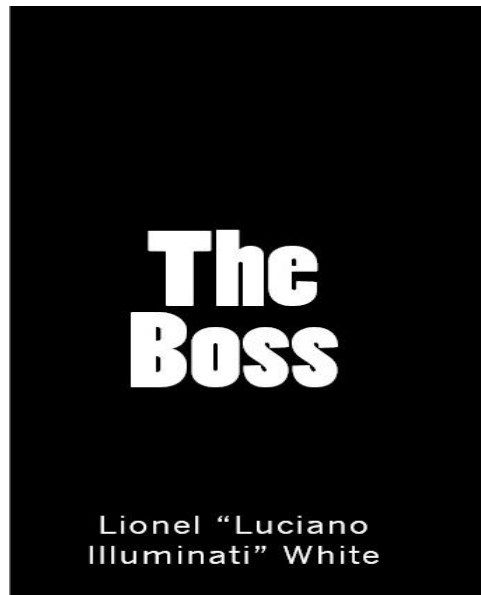

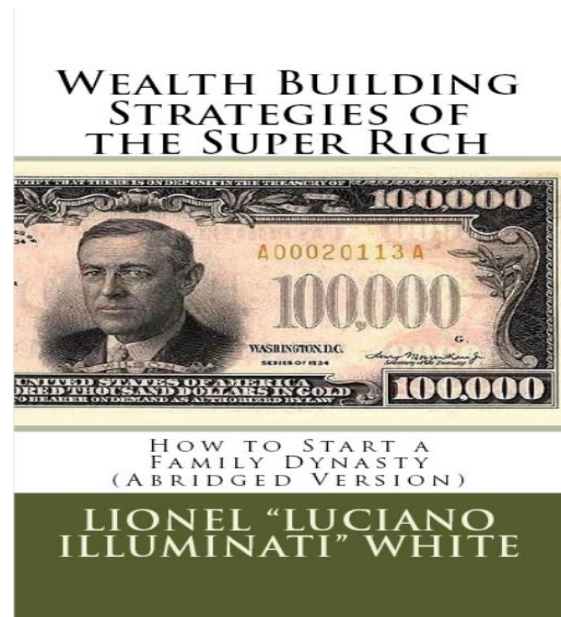

## Chapter 1

### What it means to be the boss

Being the boss means being in control of yourself and other assets for your own benefit and your family over the benefit of anyone else. Whether you are involved in legal or illegal business, it really makes no difference. It is just a matter of personal choice. Some people choose the legal side of it and other people choose the illegal side of it. It really is just two sides of the same coin.

Legal bosses punish their transgressors by suspending them, demoting them, suing them, turning them in to the authorities and firing them. Illegal bosses punish their transgressors by breaking their legs, setting their real estate on fire, threatening their loved ones and causing *them* bodily harm, turning them in to the authorities if the transgressor's interests conflict with theirs and terminating them permanently.

A drug dealer sells illegal drugs to people on the street through an elaborate system that involves many levels of manufacture, management, marketing and distribution, like "Freeway" Ricky Ross did. An alcohol, tobacco, medical marijuana or pharmaceutical company does the same thing, with drugs that have been approved by the government to be legally sold in stores.

Brothel owners, in Nevada or any other place where it is not illegal, sell the sexual services of women and men. They are licensed by the state to conduct business and their employees are required to get blood tests on a regular basis to determine if they have contracted a sexually-transmissible, venereal disease.

If they do test positive, then they can't work anymore and are fired for breaking the law that prohibits them from working as a prostitute if they have a sexually-transmitted, venereal disease.

The bosses of these establishments make a lot of sticky, sweaty money off of what is described as: "The oldest profession in the world." I can not for the life of me find the evidence that this is an actual fact, but it's what most people accept with blind faith. Any

faith that is not vested in a truly known statistical probability is always deaf, dumb and blind. It should be avoided.

The owners of pornographic video, magazine and internet businesses find, pander and then pay people to have sex. This would be illegal if there were no cameras involved. It is perfectly legal, in the states where it is legal, if you film the whole thing and then sell it as a clearly identifiable porno. This industry makes billions; legally.

These bosses face no prosecution for prostitution, but they can have their "actors" stolen away by other studios for bigger bucks – pun intended. For the common street pimp of the street game however, he faces having his hoes being stolen from him by other pimps, prosecution, and his hoes being prosecuted.

Incidentally, he doesn't really have to pay them **ANY** money and they don't have a union to cry to for help if he has to "pimp slap a bitch."

Escorts and escort services are legal most places in the United States of America. They hide behind a technicality to be able to run legal hooking operations. But everyone knows that some of the employees offer something more than what is on the menu - Bon Appetite!

Massage parlors ran by legal bosses just give massages, but ones that are ran by illegal bosses give "happy-endings" that cum with towel clean-up. Betting parlors licensed by the state are completely legal. Betting parlors that are not licensed by the state are completely illegal. People that sell bets and work for the state are called lottery officers and ones that worked for people like Charles "Lucky" Luciano, Meyer Lansky and the rest of The Commission, are called bookies.

Loaning money to people at extremely high rates of interest for very short periods of time is a perfectly legal business, if you have a business license. Car title loans are based on pledging your automotive assets as collateral. Pawn shop loans are based on pledging *any* valuable material assets as collateral. If you default on the loan, then the things that used to belong to you, become the property of the company after then.

Payday loans are based on employment and having a checking account. If you default on the loan, you still owe the money and collection agents will continue to ask you for it. They might even take it directly from your account without notice.

Loan sharks who lend money to people at extremely high rates of interest for very short periods of time are running a completely illegal business and do not have a business license. Loans are based on employment or pledging your material assets as collateral.

They will accept cars, houses, jewelry, and business shares as collateral. If you default on the loan, then the things that used to belong to you, become the property of the illegal boss in charge of the operation. You still owe more money and collection agents known as enforcers will continue to ask you for it; unless you trade your body for dollars. Or you can convince your girlfriend, wife, sister or daughter to trade sex for dollars. You might also be able to pay off your debt by committing a crime.

They will call on you at home or work or any place they can find you, when you owe a debt and have accidentally missed a payment that comes every Saturday. The interest or vig added to the first late payment, equals a visit with a punch to the body. The second equals a broken finger, rib, kneecap, an arm or a leg. The third one equals a threat and then a subsequent harming of a loved one or property and then the vig of the final late payment, equals the termination of your life.

People are not inherently good or evil. People choose whether they want to act according to the norms of the particular society that they live in. Some actions that are completely acceptable in one part of the world, are crimes in another. At one time in history you would be arrested and charged with a class A felony for conducting a certain business and at another time you would be a respectable part of the community.

Throughout history there have been bosses of all stripes, types, heights and hues. Bosses have bought and sold and leased every conceivable thing that can be bought, sold and leased to another person and have profited from it to the great benefit of themselves and their families. Conversely, there have been people who are called mooks throughout history as well.

Egypt was once the boss nation of the world. China was once the boss nation of the world. Babylon was once the boss nation of the world. The Greek Empire was once the boss nation of the world. The Roman Empire was once the boss nation of the world. Ottoman Empire was once the boss nation of the world. Great Britain was boss of the world.

The United States of America is currently the richest and most powerful nation in the world. The game of football is the most popular sport all over the world. This sport is known as soccer in the US. It is a game in which players are not allowed to hold or

touch the ball with their hands while the ball is in play. However, you can hold it over your head to toss the ball back into play from the sidelines.

The objective of the game is for players to kick or bounce a ball off their knee, chest or head up and down the field while trying to get the ball to cross through their opponent's goal past the goal tender. This very rare event scores 1 point. Halftime scores are commonly nil/nil. The championship game is called the World Cup and is watched by over a billion people worldwide.

In the United States, the game of soccer is not very popular at all. Mostly little children play it until they grow-up, and then they abandon it for more strategic games.

American Football is the most popular sport in the US. The championship game is called the Super Bowl and is watched by over a billion people worldwide. This is a game of strategic plays in which each player is allowed to hold or touch the ball at any time while the ball is in or out of play.

The objective of the game is to either kick, run or pass the ball up and down the field while trying to carry the ball into or catch the ball in your opponent's endzone, which scores a touchdown worth 6 points. The kicker kicks the ball afterwards for 1 extra point. A field goal is kicked for 3 points. The quarterback is the main player, because they put the ball into play. They decide to pass the ball to another player to run it or throw the ball to a receiver down the field.

The empire of Great Britain used to be the richest and most powerful nation in the world. The United States was just a colony of subjects of GB with limited rights, before they defeated them and gained their independence in 1785.

The US went on to gain the top spot after the late 1800s and never gave it back. The British continued to try to colonize the earth. For a century they've taught their colonists to teach soccer to the people they subjugate globally for their natural resources and cheap wage-slave labor.

This is the reason why the game of soccer is the most popular sport all over the world, except for in the United States. Soccer is a commoner's game. The British consider rugby, tennis and golf to be the sports of the upperclass or royalty and they didn't allow common people to play them. It is all symbolic of the power structure of an imperial monarchy versus a constitutional democracy.

British Football is a game where you can't hold the ball, just as commoners could not hold deeds on land in feudal times, they could not hold a title and sovereigns are all from the ruling family. The American game of football is a game where you can hold the ball, just as citizens of the United States can hold deeds to land, they can hold titles as elected officials of leadership and prestige is open to all people from any family.

Sovereigns of the US symbolically refuse to embrace a game which was considered a commoner's sport for British subjects. The US is a nation of citizens that created a game similar to rugby and also called it football, because the US is the boss nation of the world now.

The mentality of the boss is different from the mentality of the non-boss type person. You must conduct yourself based on a code of honor and respect. You must be able to manage yourself and other assets using the system of justice based on the Golden Rule.

What you do not wish others  
should do unto you,  
do not do unto them.

--- Confucius

You must live by this code and understand that if you or someone else breaks this code, then you must be punished so that the world order of the human race is maintained. This is something that has always existed throughout history in every culture and amongst every people.

If someone robs you, then they must be robbed of something too. If someone takes advantage of you, then they must have something done to them that is of an equally unwanted nature as well. If someone mistreats you or someone or something that you love, then they must be prevented from any future mistreatment to you or someone or something that you love.

This is some of what it means to be the boss. There are many elements of these things that are personal choices as to the extreme that you choose to take out this code of justice. Legal bosses usually deliver this justice in a legal way and illegal bosses usually deliver this justice in an illegal way.



The absoluteness of this distinction has been blurred and lines are crossed based on the circumstances and the individual. That is why emotions should be left out. Justice should be strictly business, not personal. If you want to be the boss, then you must learn this. You must have the skills to be a leader of yourself and others. Some people seem to be born leaders, but it is mostly a skill that is developed over time. What are the traits of a good leader?

In the Art of War, Sun Tzu puts it like this:

Leadership is a matter of  
intelligence, trustworthiness,  
humaneness, courage and sternness.

In The Prince, Machiavelli states:

It makes him contemptible  
to be considered fickle, frivolous,  
effeminate, mean-spirited, irresolute,  
from all of which a prince should guard  
himself as from a rock; and he should  
endeavour to show in his actions greatness,  
courage, gravity, and fortitude;  
and in his private dealings with  
his subjects let him show that his  
judgments are irrevocable, and maintain  
himself in such reputation that  
no one can hope either to deceive him  
or to get round him.

That prince is highly esteemed  
who conveys this impression of himself,  
and he who is highly esteemed is not easily  
conspired against; for, provided it is well  
known that he is an excellent man and  
revered by his people, he can only be  
attacked with difficulty.

The boss is a position of power in which the person has more control of his or her life, than anyone else has over their life. Landowners, Landlords, business owners, shareowners, Presidents and CEOs, Chairpersons, corporate officers, managers, intellectual content owners, politicians, contractors, gang leaders, mafia capos and Dons are all bosses.

They have power over themselves, material and human assets. In other words, the boss is the chief shareholder of his or her own destiny. Other people, your environment, and your genetics may own a minority share of your destiny, but you must own the majority of it to be considered the boss of you and others.

The boss is a person who understands the meaning of, "guilty by association." They understand that people who are something, should not waste too much time with people who are nothing. People who hold company positions, should avoid the company of people who frequently face prosecutions.

At the core of every analogy used in this publication to illustrate to you what it is to be the Boss, the Man, the Big Dog, the Big Kahuna, the Chief, the Captain, the Capo, the Don, the Lord and Master; is control.

One must have control of one's self and assets. One must live and die by the code of the Golden Rule. And one must deliver justice for transgressions when necessary. That is what it means to be the boss.
